

emart24 1ST ANNIVERSARY GIVEAWAY TERMS & CONDITIONS

1. Eligibility

- (a) The “1st Anniversary Giveaway Contest” (“The Contest”) is organised by emart24 Malaysia (“The Organiser”) and shall be held from 25th August 2022 to 25th September 2022 at 11:59 pm (“Contest Period”).
- (b) The Contest is open to citizens or permanent residents of Malaysia and above the age of eighteen (18) years with a valid National Registration Identification Card (NRIC) number (12-digit) at the time of participation (“The Participants”).
- (c) Employees of the Organiser, its subsidiaries, divisions, affiliates, authorized distributors, agents (including the advertising, public relations, marketing and interactive agencies used by the Organiser or its affiliates) and their immediate families are not eligible to enter this Contest. Immediate family means any of the following: spouse, child, parent, grandparent, sibling, uncle, aunt, niece, nephew or first cousin.
- (d) Any participation in the Contest shall be governed by these terms and conditions (“Terms and Conditions”), which shall remain in full force and effect.

2. The Contest and Submission

- (a) Participants are required to complete the following steps to participate in the Contest:
 - (i) Follow @emart24.my on Instagram and like emart24’s Facebook page. All participants must follow and like with a public Facebook and Instagram account.
 - (ii) Purchase RM30 and above in a single receipt at any emart24 store. Tobacco products and alcoholic beverages are not applicable.
 - (iii) Take a photo of the purchase receipt.
 - (iv) Upload the purchase receipt on the contest website anniversary.emart24.com.my. Participants are required to fill in all required fields in the entry form.
- (b) Only entries that complete the steps and criteria above within the Contest Period will be deemed valid.
- (c) Participants are allowed to submit multiple entries during the Contest Period, but each participant stands a chance to win one (1) prize only.

- (g) The Organiser reserves the right to appoint a third party to conduct the verification of Winners and to fulfil the delivery of prizes. Winners are to agree that the Organiser may provide all necessary information of Winners to a third party to facilitate such service.

- (d) The list of winners will be announced on emart24's Facebook and Instagram pages. Winners will be notified and informed via phone call and followed by an email.
- (e) Winners are required to provide their or their representative's name, phone number and other personal details via a Google Form to facilitate Prize collection.
- (f) In the event that a Winner cannot be contacted, The Organiser reserves the right to select another Winner.
- (g) The Organiser's decisions in relation to the Contest including but not limited to the selection of Winners and forfeiture of the Prizes are final and conclusive. No further correspondence, complaint or appeal shall be entertained.
